Under the terms of and for the purposes of the provisions of Article 17 of the Securities Code, Reditus hereby announces that it received today from its Chairman of the Board of Directors, Dr. Frederico José Appleton Moreira Rato, the following communication which it transcribes in its entirety:

"Under the terms of and for the purposes of Article 16 of CVM, the undersigned, Dr. Frederico José Appleton Moreira Rato, Tax No. 116887265, hereby informs you that he acquired, on 15 and today, on the Stock Exchange, respectively, 30,000 (thirty thousand) and 2,000 (two thousand) shares representing the share capital of Reditus, SGPS, S.A.

Due to the purchase referred to above, the signatory has become holder of 325,967 (three hundred and twenty-five thousand, nine hundred and sixty-seven) REDITUS, SGPS, SA shares which represent 5.01 % of the share capital and 5.05% of the voting rights of that company.

He also announces that the qualifying holding in question should be allocated to the entities indicated below under the terms of Article 20° of the CVM:

Esq, Lisboa, Tax No. 500 867 216, of which the signatory of this communication is a director. As you knowledge, TORA, S.A. is in turn direct proprietor of 9,750 REDITUS, SGPS, S.A. shares, corresponding to 0.15% of the capital of that company, now holding a significant stake, corresponding to 5.03% of the share capital and 5.07% of the voting rights.
